Application Process

PLEASE KNOW ALL OUR PROPERTIES ARE NON-SMOKING.

At the time, you submit your application, you will be asked to pay an application fee of \$38 payable to ORCA and a good faith fee equal to half of the rent payable to DPM. If applicant is denied the good faith fee will be returned. Upon approval, the applicant will have 48 hours to sign the lease documents and pay the balance due for the first month's rent. If applicant does not sign the lease, the good faith fee will be forfeited as damages to the owner. Security/Damage deposit and any other funds that are due will be due at the time the tenant receives the key(s) to the property, Personal checks, third party checks or cash will not be accepted during the move in process. After applicant has moved in rent payments may be paid by personal check and no third party personal checks or cash will be accepted for any payment.

DPM is required to keep all tenant application reports in the tenant's rental file and they cannot be duplicated, copied or released to anyone. If you have any questions please ask.

SIGNING OF THE LEASE WILL BE DONE MONDAY-FRIDAY 9 AM TO 5 PM. ANYONE WISHING AN APPOINTMENT OUTSIDE THESE HOURS WILL NEED TO PAY \$50 PER HOUR WITH A ONE HOUR MINIMUM CHARGE PAID IN ADVANCE.

Access to the property will be given after the lease is signed by all parties and all funds have been collected. Rent begins the day the applicant/tenant gets the keys.
